Rules: All USATT rules and regulations apply. USATT Dress Code will apply.

Equipment: 7 Cornilleau competition tables for the tournament. Butterfly 3-star orange balls. Stiga Nets. Hardwood gymnasium flooring.

Check-in: You must check in at the control desk at least 15 minutes prior to the start of your first event. If you need to leave the tournament site after you have checked in, you must notify the control desk or be liable to default. Default time is match time.

Format: RR=Round Robin. There will be small round robin groups. Top 2 rated players in each round robin group will proceed to a final single elimination round. Unrated players will advance **only** in the Unrated & Open Singles events. All games are best 3 out of 5. If there are insufficient entries for an event it will be cancelled and fees returned.
